 - All returned checks will result in a "Returned Check Fee" of no less than \$30 which must be paid immediately.
 - All invoices are to be paid 30 days from the date of the invoice. A time/price differential of 1.5% per month (18.00% APR) will be added to all past due amounts over 30 days.
- Claims arising from invoices must be made within seven working days.
- Applicant shall pay all reasonable collection fees, attorney's fees and court costs incurred by Blakely Products Co in the collection or attempted collection of any indebtedness Applicant owes Blakely Products Co. Applicant irrevocably agrees and consents that any action against applicant for collection for any such indebtedness may be brought in any state or federal court that is located in or whose district includes Blakely Products Co and that any such court shall have personal jurisdiction over Applicant for the purposes of that action. Applicant agrees that the mailing of any process by registered mail to Applicant's last known address shall constitute lawful and valid service of process.
- Applicant grants Blakely Products Co a continuing security interest in all equipment, fixtures, inventory, accounts, and general intangibles, wherever located, that Applicant now owns and in the future acquires, together with all proceeds of the foregoing, to secure payment and performance of all obligations and indebtedness of Applicant now or in the future to Blakely Products Co.
